The new General Data Protection Regulation (GDPR) is due to take effect!

We are entitled to disclose said customer data to a third party only for contractual purposes pursuant to section 6, sub-section 1 part b of the General Data Protection Regulation (EU) or for safeguarding our legitimate interest in running our business efficiently as set out in section 6, sub-section 1 part f of the General Data Protection Regulation (EU).

If we use subcontractors to provide our services, we will take appropriate legal precautions as well as appropriate technical and organizational measures to protect your personal data in accordance with applicable law. Please note that we will continue to store business data provided by you in the future to the extent described above and as necessary for conducting our business.
